Amended Rules for an "Associate" are as under

- a) An "Associate " means a person holding at least a certificate of Competency as an officer-in-charge of a "Navigational Watch", issued by a Country accepted by the CMMI Court. or
- b) A degree in "Nautical Science " from a university accepted by the CMMI Court, or
- c) A certificate of Competency as a "Dredge Master" or as a Master of "Near Coastal Vessels" (NCV) or
- d) Any other qualification considered equivalent to the above qualifications.

And

Rules for **Member** is as under

"Member" means a person holding at least a Certificate of Competency as a "Master of a Foreign going ship" issued by a Country accepted by the CMMI Court or its equivalent as decided by the CMMI Court.

Certificate of Competency (COC) issued by following other eight countries are accepted for membership of CMMI.
